The Worshipful Master then appointed a permanent building committee to oversee the construction of a new lodge hall.
- April 18, 1893: The meeting opened with a roll call and the reading of the minutes from the previous meeting. The building committee reported that they had been unable to secure a loan of \$5,000 for the construction of a new lodge hall. The Worshipful Master then authorized the committee to buy 30 shares of Kinmundy Building and Loan stock and borrow \$3,000 on paid stock.
- May 20, 1893: The meeting opened with a roll call and the reading of the minutes from the previous meeting. The building committee reported that they had been unable to secure the \$3,000 loan. The Worshipful Master then discharged the building committee and instructed the Trustees to rent the upper part of Mr. George West's new brick building for lodge purposes.
- June 3, 1893: The meeting opened with a roll call and the reading of the minutes from the previous meeting. The Worshipful Master appointed a committee to find a buyer for the Boothe property. The motion to place the property on the market for sale at the highest bidder was defeated. The Worshipful Master then instructed the Master and Wardens to make all necessary repairs to the property and keep it rented.
- October 3, 1893: The meeting opened with a roll call and the reading of the minutes from the previous meeting. The first meeting was held at the George West building. T.W. Haymond was paid for rent of his building up until this date.
- February 21, 1894: James Harvey Gray held a mortgage with Kinmundy Lodge #398 for the Boothe property.

- February 4, 1896: A committee was appointed to confer with Mr. J. E. Walls in regard to the sale of the Boothe property.
- February 18, 1896: A committee was given authority to sell the lodge's real estate as they saw fit.
- October 20, 1896: No action was taken on the suggestion to get the history of each member to be laid up among the records of the lodge.
- May 4, 1901: The Master and Wardens were instructed to transfer the lease on the building to Clipper Lodge Knights of Pythias.
- December 3, 1901: The arrangements for the new lodge dedication were made for Tuesday, January 7, 1902.
- December 4, 1901: Thomas Haymond threw himself down a well.
- January 7, 1902: Kinmundy Lodge #398 had its first meeting in their new lodge Hall.
- December 3, 1903: Kinmundy Lodge #398 is destroyed by fire.
- January 19, 1904: A new building committee is established to rebuild Kinmundy Lodge #398.

December 17, 1892: Moved and seconded that the committee on purchasing site and Building Hall for the Lodge discharged. Motion lost. On motion, the committee above mentioned was instructed to act at once. The committee on Hall and site on location reported a proposition read from Mr Lemon Ferris Boothe proposing to sell his property on Madison St, now occupied by G. Fenster (restaurant owner) and others for the sum of twenty two hundred (\$2200) dollars. One thousand dollars cash remainder on time secured by mortgage on the south part. Moved and seconded that this report of the committee so approved and the committee instructed to accept the proposition and close the deal at once. Carried.

January 7, 1893: Moved and seconded that the Master appoint a committee of three to make plans, specifications, etc. for new Hall and report at next or some subsequent meeting. Carried. The Master requested the Lodge to elect said committee. The following committee was elected; John W. Wilson, C. Rohrbough, John W. Doolen. Moved and seconded that the committee be requested to report at next regular meeting if possible. Carried. Moved and seconded that the committee on building be empowered to employ the services of an architect if desired and that the lodge pay any reasonable expenses incurred by so doing. Carried.

January 21, 1893: The committee elected to dispose of the assets of the Lodge reported that they had sold the bank stock to Thomas W. Haymond for the sum of eleven hundred (\$1100) dollars and had paid to Lemon Ferris Boothe twelve hundred (\$1200) dollars as per contract and paid. Committee had executed a mortgage on the south part of the Boothe property for one thousand (\$1000) dollars giving two promissory notes bearing even dollars for five hundred (\$500) dollars each due \$500 in one year and due \$500 in two years and had secured a warrantee deed with Kinmundy Lodge #398 A.F. & A.M. for said property. Moved and seconded that the action of the committee paying and drawing the following orders for expenses of the

Worshipful Master and amounts paid to Mr. L. F. Boothe on said property be and the same is hereby approved. Carried. Total \$1206.50.

March 4, 1893: Bill of T. W. Haymond & Co. for Hall rent three months from January 1st to March 31, 1893 \$15.00 was read and action deferred. Moved and seconded that a permanent Building committee consisting of five members be appointed by the Lodge with instruction and authority to obtain estimates of cost, plans, and specifications, negotiate money and contract for the erection of Building subject to approval of the Lodge. Carried. Moved and seconded that Calender Rohrbough, B. W. Blakeslee, A. M. Allen, A. M. Young, and W. W. Neil constitute said committee. Carried.

April 18, 1893: Moved by E. G. Forshee, seconded by C. B. Rohrbough, that the Building committee be instructed and authorized to negotiate a loan of \$5000 for the purpose of erecting a hall. Carried.

May 6, 1893: Moved by Myron M. Deiwert, seconded by A. M. Young, that the Building committee be authorized to buy 30 shares of Kinmundy Building and Loan stock and borrow \$3000 on paid stock and commence the building provided they cannot borrow \$5000 from an individual in their discretion they think best. Carried.

May 20, 1893: The Building committee made verbal report stating that said committee had failed to secure the money (viz. \$5000) for the purpose of erecting a hall. Moved and seconded that the Building committee be discharged, carried. Moved and seconded that the Trustees be and are hereby instructed to rent the upper part, one or both rooms, of Mr. George West's new brick building for lodge purposes, carried. Moved and seconded that the Trustees be instructed to place the Boothe property on the market for sale. Motion withdrawn. Moved and seconded that at the first regular meeting in June the question of the sale of the Boothe property now belonging to the Lodge be made a special order of business and the Secretary be instructed to notify the membership. Carried.

June 3, 1893: Moved and seconded that the real estate belonging to the lodge known as the Boothe property be placed on the market for sale at the highest bidder. Motion lost. Moved and seconded that the Master and Wardens be and are hereby instructed to make all the necessary repairs on the property owned by the Lodge and keep the same rented. Carried.

October 3, 1893: First meeting at the George West building. T.W. Haymond was paid for rent of his building up until this date.

February 21, 1894: James Harvey Gray held a mortgage with Kinmundy Lodge #398 for the Boothe property.

February 4, 1896: Moved and seconded that a committee of three be appointed to confer with Mr. J. E. Walls in regard to sale of lodge property known as the Boothe property. Carried.

February 18, 1896: On pages 311-312 a committee on the sale of the lodge and real estate was given authority to sell as they see fit.

October 20, 1896: Calender Rohrbough, A.M. Young, and A.M. Allen spoke of getting the history of each member to be laid up among the records of the archives of the lodge for future reference; no action taken.

During 1896, 1897, 1898 the lodge was meeting at the West building and renting out rooms of the Boothe building to several members.

The lodge during this time would often eat at Hugh Wilson's restaurant. Hugh got his degrees in 1896.

May 4, 1901: Moved and seconded that Master and Wardens be instructed to transfer lease on building to Clipper Lodge Knights of Pythias. Same to take effect upon Kinmundy Lodge vacating building. Carried.

The Summer of 1901 there were several meetings with no quorum due to excessive heat.

December 3, 1901: The arrangements for the new lodge dedication were made for Tuesday, Jan 7, 1902.

December 4, 1901: Thomas Haymond throws himself down a well.

January 7, 1902: Kinmundy Lodge #398 had its first meeting in their new lodge Hall. The following months had large turnouts for the meetings and degree work.

December 3, 1903: Kinmundy Lodge #398 is destroyed by fire.

Although it is not stated in the minutes, historical accounts state that Kinmundy Lodge met at the George West building which was now occupied by Clipper Lodge of the Knights of Pythias.

January 19, 1904: A new building committee is established to rebuild Kinmundy Lodge #398.
